Convocatorias abiertas en NEDO, que permiten cooperación extranjera, en función de la siguiente condición: The applicant should be a Japanese entity who has in Japan a suitable facility for R&D activities. However the applicant can carry out the part of the project cooperating with foreign entities (Companies, Universities, and Research Institutes) in case that it is necessary to cooperate with those entities due to the fact that those foreign entities have special R&D capabilities, and/or have special R&D facilities to carry out such part of the projects or due to the fact that it is convenient to cooperate with those entities to establish the international standard based on the result of this project.
